LUCAS COUNTY ORDINANCE No. 30

An ordinance re-adopting the existing county code and repealing certain portions therein, Lucas County, Iowa:

Be It Enacted by the Board of Supervisors of Lucas County, Iowa:

SECTION 1. <u>Purpose.</u> Code of Iowa Section 331.302 Subsection 9, requires that once every five years a county shall compile its code of ordinances. This ordinance readopts ordinances already in effect and amends certain ordinances and/or repeals any ordinance deemed no longer necessary to the operation of Lucas County, Iowa or to the health, safety, and welfare of its citizens.

SECTION 2. Re-adoption and amendment of Current Code. The following ordinances have been previously adopted and enacted into law and were duly published as the law provides.
