The Board of Supervisors met in regular session at the Courthouse on June 2, 2021, at 10.00 am with the following members present: Cathy Reece, Larry Davis, and Dennis Smith. Chairman Reece called the meeting to order, and a motion was made by Smith and seconded by Davis to approve the agenda. All voted aye. Motion carried. A motion was made by Davis and seconded by Smith to waive reading of minutes of the previous meeting and approve as written. All voted aye. Motion Carried.

A motion was made by Davis and seconded by Smith to approve the following documents. All voted aye. Motion Carried.

Motion to approve monthly expenditure report of Lucas County Veterans Affairs in the amount of \$696.02 for the month of May 2020.

Approve resolution that Luke Rich shall be hired as a full time Lucas County Deputy Sheriff effective June 12, 2021. Luke's starting pay will be \$23.60 per hour.

Approve resolution effective July 1, 2021, the pay scale for the Lucas County Sheriff's Deputies is as follows: starting pay: \$24.00 per hour; after 6 months=\$24.16; after another 6 months=\$24.33; after 2nd year =\$24.50; after 3rd year=\$25.00 and after 4th year =\$26.00.
