The Board of Supervisor's met in regular session at the Lucas County Courthouse on July 17, 2024, at 10:00 a.m. with the following members present, Cathy Reece, Larry Davis and Dennis Smith. Chairperson Smith called the meeting to order. A motion was made by Reece and seconded by Davis to approve the agenda as written. All voted aye. Motion carried. A motion was made by Davis and seconded by Reece to waive the reading of minutes of previous meeting and approve as written. All voted aye. Motion carried.

A motion was made by Reece and seconded by Davis to approve the following documents. All voted aye. Motion carried.

Approve the monthly revenue report of the Lucas County Clerk of Court for the month of June 2024, with collections in the amount of \$1,538.91.

Approve certification of the annual compensation to be received by the deputies in the Auditor's office, Treasurer's Office and Recorder's office. New employees as deputies not to exceed 78% and new employees as clerks not to exceed 73% of Annual salary drawn by said principal for one year. After one year of service, salaries for Deputies shall not exceed 80% and for Clerks shall not exceed 75% of the annual drawn by principal. Said resolution is effective on salary base beginning July 1, 2024.

Approve Per Diem resolution for County employees as follows: Mileage - .67 cents per mile; Meals - \$30.00 limit per day (in state). Overnight state required for dinner reimbursement. Out of State will be addressed individually. (Receipt must accompany claim). Hotel/Motel – Government rate, if possible, otherwise will be addressed individually.

Approve purchase order for down payment to Mon-Ray Inc. for updated Product Quotation for Mon-Ray 500 Series High Performance Storm windows. Project: Lucas County Courthouse North and South Entrance Storm Window Project. Total cost of Project \$37,240.00 with a down payment of 25%.

Approve quarterly report of Lucas County Recorder for the quarter ending June 30, 2024, with fees collected in the amount of \$19,457.46.

Approve Iowa County Treasurer's Semi-Annual report for period from 01/01/2024 – 06/30/2024. Beginning balance \$9,317,029.05. Revenues collected in the amount of \$11,399,787.69. Expenses dispersed in the amount of \$12,319,970.00. Ending Treasurers fund balance for period is \$8,440,865.40.

Conservation director Skylar Hobbs gave an update on the progress of the Pin Oak Lodge building. They are starting to move items into the building. There is much to move and organize and the mounts will have to be hung on the wall. The building will remain closed to the public until a later date after all is in place.

Lucas County Sheriff Brett Tharp gave an activity report for the fiscal year 2024 (July 1, 2023-June 30, 2024). The sheriff's office had approximately 355 calls including but not limited to 117 traffic accidents, 23 domestic cases, 8 burglaries. They made 183 arrests, booked 238 people and filed 77 Drug charges. He said they were very busy and concentrated on enforcing the law. This was done mostly with two trained deputies. The sheriff's office now has four trained Deputies. The supervisors thanked the Sheriff for activity report.
