Approve monthly expenditure report of Lucas County Treasurer for the month of September 2024 with revenue collected in the amount of \$7,528,863.74, Disbursements paid in the amount of \$2,243,136.54 and ending account balance as of September 30, 2024, was \$14,165,840.54.

Approve Bi-Monthly expenditure report of Lucas County Sheriff for the period from 10/03/2024 – 10/16/2024 in the amount of \$19,469.27.

Approve 2024 Weed Commissioner's Report.

The cost of this would be \$16,453.00 which includes the parts, labor and installation for the equipment of 30 vehicles. In addition, Advance tracking pics and system support would be \$4,980.00 for six months.
