The Board of Supervisors met in regular session at the Lucas County Courthouse on May 21, at 10:00 a.m. with the following members present: Cathy Reece and Dennis Smith. Vice-Chair Cathy Reece called the meeting to order. A motion was made by Smith and seconded by Reece to approve the agenda and deletions. All voted aye. Motion carried. A motion was made by Smith and seconded by Reece to waive the reading of minutes of the previous meeting and approve as written. All voted aye. Motion carried.

A motion was made by Smith and seconded by Reece to approve the April 2025 Revenue Report from the Lucas County Clerk of Court in the amount of \$2072.14. All voted aye. Motion carried.
