Kim Crawford, Executive Director of Circle of Freedom, was present at the meeting to thank the supervisors for the \$10,000.00 donation last year from the Lucas County Opioid Fund. Circle of Freedom provides services to women struggling with addiction across south-Central Iowa, through mentoring, weekly biblical Counseling and navigational services such as helping find services, housing, referrals, safe houses, etc. They are requesting a donation in the amount of \$13,500.00 to help with operational expenses for the residential recovery program. A motion was made by Reece and Seconded by Smith to provide the \$13,500.00 requested amount from the Opioid funding received by Lucas County for purposes like this.

Noah Schrad a representative from Senator Chuck Grassley's office introduced himself to the supervisors and those attending the meeting and leaving information on how to contact the office.
